- Highways

Cllr Caesley reported that Barton hill was damaged, and part of the road was breaking up. Dorset Council came and repaired this within 24 hours, they were thanked for their rapid response. During the merger of councils, we lost our routine gully clearance, they now only clear from the A37 to the top of Barton Hill once a year. To add the other gullies (not on the main line) would cost £270.38, or a complete gully clearance would be £493.20. **It was proposed that the council fund for all 45 gullies for 1 clean per year costing the council £270.38, proposed by Cllr Caesley, seconded by Cllr Smith. Review before Winter 2022.**
